### 1 Background

RESS 4 is the fourth Onshore Renewable Electricity Support Scheme by the Government of Ireland and is a pivotal component of the Programme for Government and the <u>Climate Action Plan 2024</u> RESS 4 uses a competitive auction process to determine which generators receive support. For projects that are successful in the RESS 4 Auction, this support typically applies for approximately 15 years.

The RESS 4 Auction ran as per the <u>RESS 4 Auction Timetable</u> following the Auction Submission Closing Date on the 28/08/2024. The aim of this document is to publish the Provisional Auction Results determined by EirGrid in respect of the RESS 4 Auction, as set out in Section 8.5.1 of the <u>RESS 4</u> <u>Terms and Conditions</u>

The Provisional Auction Results are subject to approval and the reserved rights of the Minister for the Environment, Climate and Communications as set out in Section 12 of the RESS 4 Terms and Conditions.

### 2 Qualification

A total of 56 projects applied to participate in the RESS 4 qualification process. The Final Qualification Results, as approved by the Minister for the Environment, Climate and Communications, qualified 43 projects to participate in the RESS 4 Auction. 3 projects did not qualify, and 10 projects formally withdrew from the process.

The RESS 4 Auction submission window for Offer Prices opened on 22/08/2024 at 10:00 and closed on 28/08/2024 at 12:00. Of the 43 projects that qualified to participate in the RESS 4 Auction as approved by the Minister, 43 projects submitted an Offer Price for their project via the RESS Auction Platform before the deadline of 12:00 on 28/08/2024.

EirGrid ran the auction on the afternoon of 28/08/2024. Of the 43 projects who submitted an Offer Price in respect of the RESS 4 Auction, 27 projects have been provisionally successful in the auction and 16 projects have been provisionally unsuccessful in the auction.

### **3 RESS 4 Auction Timetable**

Table 1 sets out dates for the main milestones of the RESS 4 Auction in accordance with the RESS 4 Terms and Conditions. The publication of this report represents the completion of the Provisional Auction Results milestone.

## 4.2 Deemed Energy Quantity Provisionally Successful and Unsuccessful




Figure 1 Deemed Energy Quantity Provisionally Successful and Unsuccessful by Eligible Technology

A total Deemed Energy Quantity of 2070.97 GWh was provisionally successful and a total Deemed Energy Quantity of 513.23 GWh was not successful. Figure 1 shows the Total Deemed Energy Quantity (GWh) Successful and Unsuccessful by Eligible Technology.




Figure 2 Offer Quantity Provisionally Successful and Unsuccessful by Eligible Technology




Figure 3 Location of RESS 4 Provisionally Successful Projects by Eligible Technology
