

Agreed Procedure 1: Registration


Procedure Overview

- The Registration Agreed Procedure covers the processes for accession to the Code and registration of units and parties, as well as for access to relevant systems (access rights, data update, etc)
- The key processes are:
 - Code Accession
 - Party Registration (to become a Service Provider)
 - Unit Registration
- Drafting is based on the TSC Registration Agreed Procedure, noting that the Meter Data Provider role is not relevant for System Services.
- Content in Sections 2.4 - 2.6 is systems-dependent and will be revised as further detail is available during the design/implementation work.

Accession




Overview

- The System Services Code Accession process is similar to that for the TSC, though managed by the TSOs.

Conditions and Required Information

- Director's Declaration regarding due execution of the Accession Deed
- Documents the TSO may request to ensure satisfaction of due execution (e.g. company constitution extracts, Board Resolutions etc.)
- Pay the Accession Fee ;
- Be registered as a Party under the Trading and Settlement Code where necessary as per section 4.1; and
- When provided, execute the Accession Deed to adhere to the System Services Framework Agreement and this Code.

Party Registration




Overview

- Party Registration will be the process for Parties to become Service Providers.
- Service Providers can participate in the DASSA and Secondary Trading, subject to registration and qualification of their units.
- Unit registration can take place in parallel to Party Registration.


Unit Registration: Stage 2 - Review and Validation



Overview

- In this stage, the System Operators will review the Registration Data and request clarifications if needed.
- If applicable there will be review from External Data Providers.

Unit Registration: Stage 3 - Finalisation of Registration



Overview

- In the Finalisation stage, the Effective Date is determined, and Credit Cover is posted by the Applicant.
- Once all outstanding actions are complete, the Commencement Notice is issued.
- The list of Units registered in the System Services markets is updated by the System Operator.

Agreed Procedure 18: Suspension and Termination



Procedure Overview

- The Suspension and Termination Agreed Procedure covers
 - Deregistration
 - Voluntary Termination
 - Suspension
 - Issue of a Termination Order; and
 - Intermediary removal
- Drafting closely follows the TSC Suspension and Termination Agreed Procedure, however changes to drafting may be required in the future as more detail on Defaults and Suspension arrangements becomes available.
- Some aspects are not relevant e.g., those relating to the Supplier of Last Resort mechanism.
- There may be interactions between Suspension under the System Service Code and Trading and Settlement Code - these will be considered in future work.


Deregistration and Voluntary Termination



Overview and Timelines

- Deregistration and Voluntary Termination are conditional on there being no remaining payments due or obligations under the Code.
- The Deregistration Form must be provided 40 WD prior to the Deregistration date.
- For Voluntary Termination, notice must be received 90 WD prior to Voluntary Termination taking effect.


Issuing a Suspension Order and Suspending a Party



Overview

- Suspension Orders would be sent with the approval of the Regulatory Authorities, following a Default Notice.
- If the Default is not remedied and lifted prior to the date of effect in the Suspension Order, the System Operator will confirm and apply the suspension.
- Interactions with suspension under the TSC will be further determined as part of future work.

Agreed Procedure 14: Dispute Resolution


Procedure Overview

- The Disputes Agreed Procedure covers:
 - Raising the various types of Disputes (Pricing, Settlement Query, General);
 - Appointment of the System Services Dispute Resolution Board (SSDRB);
 - The timescales and procedures associated with a decision of the SSDRB;
- Drafting is closely aligned with the equivalent TSC procedure.

Raising a Dispute




Overview

- Disputes are raised by sending a Notice of Dispute.
- Once a Dispute is raised, the TSOs will inform Affected Parties and co-ordinate a meeting to resolve the Dispute by negotiation.
- If negotiation is unsuccessful, the Disputing Party may refer the Dispute a System Services Dispute Resolution Board.
- A Settlement Re-Run may be required.

Comparison with TSC arrangements

- General or Other Disputes at step 1d must be raised within 1 year of the Disputed Event (rather than 2 years as under the TSC).

System Services Dispute Resolution Board Composition




Overview

- The SSDRB will have a single member, unless one of the following conditions are met, in which case it will have 3 members:
 - There are more than 2 Disputing Parties
 - The Disputing Parties cannot agree on the number of members or agree to 3 members.
- Where the Disputing Parties cannot agree on the selection of member(s) (or the number of members), the SSDRB chairperson will appoint the members. Otherwise:
 - If a Single member SSDRB: The Disputing Parties agree the single member.
 - If a 3 member SSDRB: The Disputing Parties each appoint one member. The appointed members then appoint a third member.

Comparison with TSC arrangements

- In there is no agreement on number of members on the SSDRB, there will be 3 members (rather than 1 member).

System Services Dispute Resolution Board Decision




Overview

- Information will be provided to the SSDRB to enable its decision-making (the SSDRB may request further information).
- The SSDRB makes its decision and notifies the Parties, including the SO and the RAs. It may request additional time if required.
- If a Disputing Party is dissatisfied with the decision and the Dispute cannot then be settled amicably, it may refer the matter to a Court.
- For a Pricing Dispute, the SSDRB will assess the Dispute against the Price Materiality Threshold.
