1. Introduction

This section provides an assessment of the potential route corridors within the study area for the proposed 110kV line from Clashavoon to Dunmanway, Co. Cork. The purpose of this assessment is to recommend the route corridor that causes the least Cultural Heritage impacts.

A previous Constraints Report identified the most significant Cultural Heritage constraints within the study area. The potential route corridors have been designed having regard to the identified constraints.

2. Assessment of Route Corridors

A desk-based route selection report was undertaken for three potential route corridors between Clashavoon townland (northeast of Macroom) and Dunmanway, Co. Cork to highlight areas of potential archaeological sensitivity and to identify all recorded cultural heritage sites that may influence the selection of the potential routes for the proposed electricity transmission line. The routes include an eastern route corridor, a central route corridor and a western route corridor. A number of options within each corridor were also included.

The aim of the route selection report is to assess each of the route corridors for their archaeological landscape potential and map each route showing the identifiable cultural heritage sites that may impact on choosing one route over another for the proposed electricity transmission line. For the purposes of this report, **cultural heritage** is considered to include the following elements:

- Sites listed in the Sites & Monuments Record (SMR)
- Record of Monuments & Places (RMP)
- Sites listed in the Archaeological Inventory of Mid Cork and West Cork
- Archaeological sites listed on the National Monuments Service website: www.archaeology.ie
- Sites listed in the Record of Protected Structures (RPS)
- National Inventory of Architectural Heritage, Buildings of Ireland: www.buildingsofireland.ie
- Sites uncovered in Excavations Bulletins

Eastern Route Corridor

National Monuments

No *National Monuments* in State Care/Ownership are located within the Eastern Route corridor. Kinneigh Round Tower RMP CO094-104/002 National Monument No. 618 and RPS no. 603 is located 274m south of the northern alternative (Nodes 9-10) and 782m northwest of the southern alternative. The correspondence from the DAU (Ref G2010 407) of the Department of the Environment Heritage and Local Government has stated that 'all National Monuments in State Ownership or Guardianship... should be identified and zones of visual amenity defined for them'. Ideally pole sets and pylons should not be visible from sites which are National Monuments.

Record of Monuments and Places (RMP) and Sites and Monuments Record (SMR)




Figure 2.1: Map showing Eastern route corridor and Recorded Monuments.

One hundred and three monuments occur within this corridor. Three are now redundant monuments leaving 100 recorded monuments which are outlined in *Figure 2.1* and *Table 2.1* below. Clusters of monuments and those which are prominent in the landscape will be highlighted here to assist in the route selection process.

An ecclesiastical enclosure (RMP CO071-108) and associated monuments (churches, bullaun stone, cross slab and graveyard) is located centrally within this corridor (nodes 4-11) in Bawnatemple townland. This complex occurs as a cluster of monuments, therefore traversing the monuments by a transmission line may potentially result in dividing the 'landscape' or have a visual impact on the monuments.




Figure 2.2: Ecclesiastical complex CO071-108 at Bawnatemple Td.

Another cluster of Bronze Age monuments are located at Rusheen Townland (Node 4-13) and consist of two standing stones and two radial stone cairns (CO060-205 &206 and CO060-202/01 and 02, respectively). This group of sites occurs at the northern end of the eastern corridor. The positioning of polesets and angle masts in the route selection process has the potential to divide an identified archaeological landscape and may potentially have a visual impact on the latter. It is preferable that the transmission line would not traverse the sites in order to avoid any potential visual impacts.

Another small cluster of Bronze Age monuments (Fulachta Fiadh CO071-126, 145-146) is located at Coolalta (nodes 12a-13). The sites are located centrally within the corridor. Positioning the transmission line to either the west or east of these monuments would be preferable to avoid any direct impacts. Fulacht fia are largely low lying monuments and visual impacts would therefore be unlikely to occur.

A cluster of monuments (i.e. 10 fulacht fiadh) are located at Killinardrish and Bawnatemple townlands (Node 12). While it is possible for polesets and angle masts to avoid these monuments the large number of fulachta fia in the area may be indicative of the presence of further sub-surface remains.




Figure 2.3: Cluster of Fulachta Fia at Node 12.




Figure 2.4: Extract from RMP map Sheet 108 showing Ecclesiastical Enclosure 027.




Figure 2.5: Ecclesiastical Enclosure CO108-027 indicated by arrow.

An ecclesiastical enclosure (CO108-027) and associated church and graveyard is located at Nedinagh East (Node 1-9). The actual size and extent of the monument is not realistically represented by the red dots on *www.archaeology.ie* (*Figure 2.3*). The actual extent of the enclosure is shown in *Figure 2.4* above. The size and extent of this monument should be borne in mind when placing polesets and angle masts. The transmission line ideally should not traverse or span the enclosure but should be confined to either side of the monument.

Protected Structures

No protected structures are located <u>within</u> the Eastern route corridor. A Round tower (RPS no. 603), however, which is also a Recorded Monument and a National Monument is located 274m to the south of the northern-most route alternative (node 9-10). The location of this prominent structure should be considered during the route selection process.

Central Route Corridor

National Monuments

No *National Monuments* in State Care/Ownership are located within the central route corridor. The nearest monument 'Cahervagliar ringfort' RMP CO094-060/001 National Monument no. 233 is located 809m to the east of the corridor (nodes 6-7). This is considered an adequate distance from the corridor thus allowing the zone of visual amenity to be preserved.

Record of Monuments and Places (RMP) and Sites and Monuments Record (SMR)

Forty six (46) recorded monuments are located within the central route corridor. One is now a redundant record leaving the total number of monuments at 45. *Table 2.2* shows the total number of monuments which occur within the route corridor.




Figure 2.6: Map showing central Route Corridor and Recorded Monuments.

No clusters of monuments occur within this route corridor and the majority of the Recorded Monuments are well distributed. A number of instances where monuments are located at the centre of the corridor do occur however. This may result in the transmission line traversing monuments such as the stone circle CO071-100 at Rosnascalp Townland (Node 4-8). Traversing such monuments in the final selection process should be avoided. Placing polesets and angle masts at a remove from such monuments would be preferable. Another example would be the Church and Country House CO083-020/002 and 001 at Crossmahon (Node 8). Placing angle masts and polesets in areas where such prominent monuments occur should be avoided. Another example is Crowley's Castle (RMP CO094-051) in Ahakeera (Node 5-7). This structure is still upstanding and ideally should not be spanned by the transmission line. The corridor between node 7 and 8 may be a better alternative in this regard.

Protected Structures

Two (2) protected structures are located within the central route corridor. Crossmahon House (RPS 546) which is also a Recorded Monument is located centrally within this route corridor (Node 8). A protected structure can also include the attendant grounds of the building in question therefore placing polesets or angle masts within the immediate vicinity of this structure may have a potential visual impact. Another protected structure (Ardaneneen House No. 547) is located in Ardaneneen townland (Node 7-8). The same principals apply as Crossmahon House. No other protected structures are located within this route corridor.

Western Route Corridor

National Monuments

One *National Monument* (Carrigphooca Castle RMP CO070-034, National Monument No. 255, RPS no. 422) is located within the Western Route Corridor (Nodes 3-4). This is a prominent monument in the landscape and a well visited site. It is possible that the zone of visual amenity as requested by the DoEHLG would be impacted on by the location of a transmission line in this area. Although, the size and extent of the requested zone of visual amenity is not defined by the DoEHLG, ideally the transmission line should not be visible from the National Monument and *vice versa*.




Figure 2.8: Map of 3 route alternatives showing National Monuments. Note only western route corridor contains a National Monument.

Record of Monuments and Places (RMP) and the Sites and Monuments Record (SMR)

Forty-eight (48) Record of Monuments and Places (RMP) and the Sites and Monuments Record (SMR) recorded monuments are located within the western route corridor and these are outlined in *Table 2.3* below. No large clusters of monuments occur within this route and the recorded monuments are largely well distributed.




Figure 2.9: Map showing western route corridor and Recorded Monuments.

A children's Burial ground / Ecclesiastical Enclosure (CO059-186) is located centrally in this route corridor (node 3-4). The actual size of the enclosure is not represented by the red dots on *www.archaeology.ie* and this should be taken into consideration when positioning polesets and angle masts.




Figure 2.10: Extract from RMP Sheet 59 showing Children's Burial Ground 186.

Carrigphooca Castle RMP CO070-034 is located centrally along this route corridor (Node 3-4). This monument is also a National Monument and has been addressed above.

A stone row CO082-005 and standing stone CO082-004 (Bronze Age Monuments) are located in Cloonshear Townland (Node 2-3 east). These monuments are connected by a passageway and are associated sites in terms of date and function. The transmission line should ideally not traverse these sites but rather be placed either to the east or west of the monuments. To the south of the latter monuments is a castle CO082-008 in Carrignaneelagh townland (Node 2-3 east). This structure has no above ground trace therefore the transmission line will not have any visual impact on such a structure.

Protected Structures

Four (4) protected structures are located within this route corridor. Carrigphooca Castle (RPS 422), which is a protected structure is located within the western route corridor. This structure is also a National Monument and a Recorded Monument and

has been address in the section above under National Monuments. A second protected structure Carrigphooca Country House (No. 833) is located on the western periphery of this route corridor (node 3-4). A limekiln (RPS 420) is located centrally in this route corridor just to the south of a public road in Garranenagappul townland (node 3-4). The location of this structure must be taken into consideration during the route selection process. Hanover Hall (RPS 375) is located in Coolanidane townland (node 3-4).




Figure 2.11: Record of Protected Structures (RPS) within each route alternative

3. Selection of Preferred Route Corridor

The overall objective of this route selection report is to highlight cultural heritage sites within each route so that an informed decision can be made regarding the avoidance of cultural heritage features during the route selection process. A general impact statement will be made regarding each route alternative and a preferred route will be chosen. Cultural heritage sites include Recorded Monuments, Protected Structures and National Monuments. Only the available documentary and cartographic sources were utilised in order to assist in the route selection process.

Eastern Route: This route contains 100 cultural heritage sites five of which are large clusters of monuments. Many of the clusters of sites date to the same period indicating the presence of archaeological landscapes. One example is the presence of 10 fulachta fia within close proximity to each other (Section 4.3.2 (node 12)). This may be indicative of a Bronze Age landscape and an area that was intensely utilised in the prehistoric period. Two ecclesiastical enclosures and associated monuments are located at Bawnatemple and Nedinagh East. The extent of these monuments on the ground should be considered during the route selection process. Ecclesiastical enclosures can often measure in excess of 200 metres in diameter. Nodes 4-11 route alternatives both contain large clusters of monuments. The southern alternative of node 9-10 would be more preferable than the northern route on the basis that it contains fewer monuments.

Central Route: This route contains 47 cultural heritage sites and does not include any National Monuments. No large clusters of monuments are located within this route therefore fewer potential impacts (direct and indirect) on cultural heritage sites are anticipated. Furthermore, there are lengthy stretches of land with no recorded monuments present. One example is between Rosnascalp and Curragh townlands (nodes 4-8) and Teerelton to Baulbrack townlands (nodes 7-8). Node 6-7 is more preferable than 5-7 on the basis that there are fewer recorded monuments. Nodes 6-5-1 is devoid of Recorded monuments and is the preferable route when compared to nodes 6-1 (eastern alternative).

Western Route: This route contains 53 cultural heritage sites one of which is a National Monument in State Ownership (Carrigphooca Castle). The DoEHLG have requested that a zone of visual amenity be established around Carrigphooca Castle which is a Recorded Monument, National Monument and a Protected Structure. While this zone is not defined in terms of size or distance, a zone of 300m was suggested in the initial constraints report. In order to negate any potential visual

impacts on the castle it is recommended that polesets and angle masts should not be visible from the monument and *vice versa*. While this route does not contain any large clusters of monuments a number of recorded monuments are located centrally within the route. Conversely, there are few recorded monuments located between nodes 2-3 (western alternative).

4. Preferred route

The preferred route option is the central route corridor on the basis that it contains the least number of cultural heritage sites. Furthermore, it does not contain any clusters of archaeological monuments or National Monuments.

The western route corridor is also acceptable on the basis that Carrigphooca Castle would be excluded from same.

The eastern route corridor is the least preferred option due to the high number of cultural heritage sites therein. It also contains clusters of archaeological monuments which may be indicative of archaeological landscapes.
