

Proposed Clashavoon - Dunmanway Electrical Reinforcement Scheme Public Information

EirGrid is the state-owned independent electricity Transmission System Operator and Market Operator in Ireland. It is EirGrid's role to develop quality connection, transmission and market services to electricity generators, suppliers and customers utilising the high voltage electricity system.

In this capacity, EirGrid is proposing a new 110kV electricity circuit to connect the existing Clashavoon substation, which is located north-east of Macroom, and the existing Dunmanway electricity substation, which is located on the outskirts of Dunmanway.

It is vital that the new electricity infrastructure is built to ensure that the region meets the standards required of a safe and secure electricity system and to utilise the South West region's rich renewable energy resources.

EirGrid is committed to ensuring that all work will be undertaken in a safe and environmentally responsible manner and in co-operation with the local community.

Following the completion of the Phase 2 consultation and engagement period, the Phase 2 Lead Consultants Report, identifying the preferred route corridor and the indicative overhead line route has now been published.

The preferred route corridor, indicative overhead line route and copies of the Phase 2 Lead Consultants Report will be available to the public to view between the 29th July and 26th of August 2011 at the locations below.
