



## DS3 System Services Regulated Arrangements - Gate 9

The tables below summarise the contracted volumes for the Ireland and Northern Ireland Agreements for the DS3 System Services Regulated Arrangements, effective from October 1st 2023. **Note:** The volumes contracted in Gate 9 are given in the first row of each table; these figures include new units and any existing units that have amended their contracted capability. Some existing contracted providing units submitted tenders for lots in error or submitted tenders that ultimately did not result in any change to contracted capability following testing and some units submitted tenders to amend existing contracted capability but decided to no longer contract for a service prior to contract execution. These lots are not included in the notified awarded contracts/volumes. The total contracted volumes reflect the current contracted volumes per service at October 1st 2023.
