## 1. DS3 System Services Interim Tariff Rates

The table below sets out the payment rates applicable to DS3 System Services Interim arrangement<sup>1</sup>. This is in line with the DS3 System Services Interim Tariffs decision paper<sup>2</sup> published on 24<sup>th</sup> August 2016.

### 2. Rate of Change of Frequency Incentive Mechanism

The Rate of Change of Frequency (RoCoF) remuneration mechanism was approved in the following SEM committee Decision paper<sup>3</sup> (SEM-16-021) which was published on 31 May 2016. It provided for the daily early incentive payment rates effective from 1<sup>st</sup> March 2016 to 31<sup>st</sup> May 2016 for all eligible units and 1st June 2016 to 28th February 2018 as set out below in Table 1 & 2 below.

The payment is scaled in a fashion that the day rate decreases in each six month period. The table below sets out the daily payment rate effective from 1<sup>st</sup> June 2016 to 28<sup>th</sup> February 2018 for all eligible units:
