## **DS3 System Services Enduring Tariff Rates**

In July 2017 a consultation paper¹ was published by the TSO detailing the DS3 System Services tariff rates that will apply to the Enduring Framework Agreements contracted from 1 May 2018, for the existing 11 services and the 3 new services.

Following consideration of the responses to the consultation, a recommendations paper<sup>2</sup> was submitted to the SEM Committee.

The SEM Committee published a decision paper<sup>3</sup> on 24 October 2017 approving the tariff rates applied to contracted services from 1 May 2018 for the 11 existing services and the 3 new services, as detailed in table 1.
