## East West Interconnector is Safe

An Independent Health Expert Opinion commissioned by Minister Eamon Ryan has confirmed that the EirGrid West Interconnector poses no health risk.

Eric van Rongen, PhD, a radiobiologist and an internationally recognised expert in health effects of electromagnetic fields confirmed that "...there are no indications that exposure to the static magnetic fields generated by the HVDC cable will in any way adversely affect human health, neither through acute nor through long term effects. The risk associated with this exposure can be considered to be as close to zero as possible".

EirGrid welcomes the report which backs up the information provided by EirGrid's independent expert Dr William Bailey, who is the international expert in electromagnetic fields who gave evidence at the An Bord Pleanála oral hearing in relation to the Interconnector, and it also backs up information which has been provided by the Irish Government.

The static magnetic field generated directly above the Interconnector is 43 microTesla which is less than the earth's natural magnetic field which is 49 microTesla in Ireland.

Mr van Rongen stated, "Everybody in Ireland and the rest of the world has been continually exposed to the geomagnetic fields throughout his or her lifetime. There are no indications at all that such exposure may lead to adverse health effects".

The East West Interconnector will operate far, far below the latest international guidelines which are set by the International Commission on Non-Ionizing Radiation Protection (ICNIRP) which is a body of independent scientific experts in non-ionising radiation and is formally recognised by the World Health Organisation.

The ICNIRP guideline for general public exposure is 400,000 microTesla, many times that of the field from the interconnector. To compare this to everyday sources of static magnetic fields, the earphones of a portable music player generate 28,000 MicroTesla and a fridge magnet generates 22,000 microTesla, and they are accepted as perfectly safe.

EirGrid Project Director, John Fitzgerald said "The Department of Communications, Energy and Natural Resources' Independent Expert Opinion reconfirms that the East West Interconnector is safe and poses no health risk to anyone living along the route of the cable".
