In May 2016 the title of the Transmission Planning Criteria was changed to the Transmission System Security Planning Standards (TSSPS). The title of the document was changed as per the Transmission System Operator License. At the time the Grid Code was never modified to take account of the new title.

If this recommendation is not approved the Grid Code will continue to reference a title that no longer exists.
