The Reason for the Recommended Modification:

Demand Side Unit Operator System Operator Interface Agreements have been in use for a number of years. The agreements are already in place between the TSO and the vast majority of the existing Demand Side Unit Operators. The purpose of this proposal is to recognise the use of these agreements and to describe who the agreements apply to.

The modification was originally presented at the 10 May 2023 GCRP meeting. A query was raised by the GCRP member, Vlastik Buzek, regarding if the use of the Demand Side Unit Operator System Operator Agreement should be included in the Demand Side Unit Operator definition. A follow-up meeting between Vlastik Buzek, Deirdre Hughes (EirGrid) and Miriam Ryan (EirGrid) took place on 8 June 2023. During that meeting, the inclusion of the reference to Demand Side Unit Operator System Operator System Operator System Operator Agreement in the Demand Side Unit Operator definition was agreed and the proposed modification was updated accordingly.

A further revision to the proposed modification to the definition of Individual Demand Site, the inclusion of the text "This includes where" as proposed by Paul Troughton at 10 May 2023 GCRP, has also been included as part of this revision.

History of Progression through GCRPs, Working Group and/or Consultation:

Version 1 of the proposed modification was presented at the EirGrid GCRP on 10 May 2023, where it received feedback and a decision was made to undertake further work on the proposed modification. On the 28 June 2023, version 2 of the modification proposal was presented to the EirGrid GCRP members.

No objections were raised by the GCRP members to version 2 of the proposed modification.
