## 1. Introduction

The aim of this Auction Information Pack is to provide information to ORESS 1 Qualified Applicants to enable them to participate in the ORESS 1 Auction process.

Submission of Offer Prices for Qualified Applicants shall be facilitated through the RESS Auction Platform which Applicants previously used to submit their Applications for Qualification.

In this Auction Information Pack, ORESS 1 Qualified Applicants will find the most recent auction timetable and information that will inform them fully on the auction process and parameters. One form is included in this Auction Information Pack, namely the Notice of Auction Dissatisfaction form.

The key items included in this Auction Information Pack include:

- ORESS 1 Auction Timetable (OR1AT)
- ORESS 1 Auction Process (OR1AP)
- ORESS 1 Notice of Auction Dissatisfaction (OR1NAD)
- ORESS 1 Parameters
- ORESS 1 RESS Auction Platform Connectivity Information and Offer Submission.
- Standstill Period (Appendix A)

All information found within this pack is based on the <u>ORESS 1 Terms and Conditions</u>. Where there is a difference between this Auction Information Pack and the ORESS 1 Terms and Conditions, the latter takes precedence. ORESS 1 Qualified Applicants should ensure they are fully aware of the obligations that arise in the ORESS 1 Terms and Conditions.

This Auction Information Pack will explain the background to each of the documents included herein.

## 3. ORESS 1 Auction Timetable

The latest ORESS 1 Auction Timetable (OR1AT) is included in this Auction Information Pack.

### 4. ORESS 1 Auction Process

The ORESS 1 Auction Process (OR1QIP) contained in this pack includes a detailed step-by-step guide to enable ORESS 1 Qualified Applicants to clearly understand exactly what is required of them to participate in the ORESS 1 Auction from the Auction Information Pack Publication Date to Final Auction Results Date. Timings of key activities are also illustrated in the process in line with the dates identified in the ORESS 1 Auction Timetable. The ORESS 1 Auction Process consists of the steps associated with submitting an Offer Price, running the auction and issuing Provisional and Final Auction Results.

## 5. ORESS 1 Notice of Auction Dissatisfaction

An Applicant who, following a TSO decision with respect to the Provisional Auction Results, considers that the TSO has not applied the Terms and Conditions correctly in their determination of the Provisional Auction Results, can submit a Notice of Auction Dissatisfaction (OR1ND) to the Minister (copying the TSO). The Applicant should detail the relevant provisions of the ORESS 1 Terms and Conditions that they consider have not been applied correctly by the TSO.

The Notice of Dissatisfaction must be received by the Minister no later than <u>two</u> working days after receipt of the Provisional Auction Results.

It is preferable that this document is typed and if this is not possible it must be completed using block capitals. For the avoidance of doubt, the document should be completed, printed, signed by the authorised user and sent to <a href="mailto:oress@Decc.gov.ie">oress@Decc.gov.ie</a> copying <a href="mailto:RESS@eirgrid.com">RESS@eirgrid.com</a>.

### 6. ORESS 1 Parameters

In accordance with 6.2.3 of the ORESS 1 Terms and Conditions, the final values of the RMin and RMax, as approved by the Minister, are as follows:

If the Regulatory Authority determines there is insufficient competition with which to conduct

an auction a statement to this effect will be published before the ORESS 1 Auction Submission Deadline Date. Otherwise, the Final Competition Ratio will be published by the Regulatory Authority no later than the Provisional Auction Results Date.

# 7. RESS Auction Platform - Connectivity Information

The RESS Auction Platform that was used by the Applicant to complete and submit an Application for Qualification in respect of the ORESS 1 Auction will be used to submit Offer Prices, which will be used in the auction algorithm.

An Offer Price will only be accepted by the TSO if it is submitted by a RESS Authorised User. The same login credentials issued for the qualification phase should be used to access the Platform to submit Offer Prices.

Similar to the qualification stage, an Applicant will be issued with a code to their mobile phone which must be entered to complete the logon. This is to ensure a high level of security on the Platform.

Should an authorised user forget their password, they can email the RESS Team at <u>RESS@Eirgrid.com</u>. Alternatively, another Authorised User for the same project can reset the password for other users.

The contact email address for those experiencing difficulties accessing the RESS Auction Platform is RESS@Eirgrid.com.

## 8. RESS Auction Platform - Offer Submission

An applicant will submit their Offer Price within the RESS Auction Platform (RAP). When an authorised user accesses the RAP, they will need to navigate to the Offer Price tab within their Application for Qualification (AfQ) as highlighted in Figure 1 below. All other tabs on the Platform will be locked.

There are two mandatory fields that need to be completed on the Offer Price tab:

- 1. €/MWh and is less than or equal to [150] €/MWh; and
- 2. Confirmation that all information provided in the Application for Qualification remains true and accurate in all respects as of the date of submission of Offer Price including:

a) subject to Section 6.3.8 and Section 6.3.10, that all information provided in the Application for Qualification remained true and accurate in all respects throughout the Standstill Period and that it

remains true and accurate in all respects as of the date of submission, with the only exception being any information for which a change of status, or change of the information itself, was approved and accepted in writing by the TSO within the Standstill Period - for example in the case of change of contact details pursuant to Section 6.3.10.

- b) that the information submitted to Department of Environment, Climate and Communications (DECC) in the Financial Questionnaire set out in Annex B of the Terms and Conditions remains true and accurate at the time of submission.
- c) that the information submitted to Department of Environment, Climate and Communications (DECC) in the Project Information Document set out in Annex B of the Terms and Conditions remains true and accurate at the time of submission.
- d) that the information submitted to Department of Environment, Climate and Communications (DECC) in the Project Information Document set out in Annex B of the Terms and Conditions remains true and accurate as at the date of the Offer in respect of the ORESS 1 Project: and

The Offer Quantity submitted in respect of the ORESS 1 Project is based on, and consistent with, the information contained in the Project Information Document and Declaration of Project Information (OR1DPI).

Once these details are populated, there is only one option which is 'Submit Offered Price'. Once this is selected, the Offer Price entered is final and there will be no option for the Authorised User to amend this. There is no option to enter details and save this entry to review at a later date. Therefore, before selecting the 'Submit Offered Price' button, please carefully review the details entered before submitting.

## ORESS 1 Anonymous Financial Questionnaire

Qualified Applicants must complete and submit the Financial Questionnaire found in Annex B of the ORESS 1 Terms and Conditions to the Minister (to be submitted for the attention of ORESS Team, International and Offshore Energy Division at the address specified at Clause 13 of the Implementation Agreement) no earlier than the Financial Questionnaire Submission Opening Date and no later than the Financial Questionnaire Submission Closing Date. The information submitted in this Financial Questionnaire must be true and accurate at the time of submission.

Please note the Financial Questionnaire must not be submitted to EirGrid.

### Appendix A- DECC Notice of Standstill Period

#### Standstill Period

Qualified Applicants are reminded that they are now in the <u>Standstill Period</u>, as that term is defined in the ORESS 1 Terms and Conditions.

All persons, entities and parties meeting any of the conditions set out in Section 6.3.8 of the ORESS 1 Terms and Conditions, being third parties or otherwise, must by now have been disclosed in the Declaration of Bidding Independence.

In accordance with section 6.3.8 of the ORESS 1 T&Cs, at the time of the ORESS 1 Auction Submission Deadline Date, Qualified Applicants will be required to confirm that all information provided in their Declaration of Bidding Independence has remained true, correct and accurate in all respects throughout the Standstill Period.<sup>[1]</sup>

The consequences of non-compliance with these provisions are significant and are set out in Section 6.6.3.

The provisions of Section 9.2.6 of the ORESS Terms and Conditions are as follows:

#### 9.2.6 Standstill Period

- (a) During the Standstill Period, Applicants shall not reveal Pricing Information to third parties that were not disclosed pursuant to Section 6.3.8(c)(i), excluding any finance provider or advisor bound by confidentiality obligations restricting the disclosure of such Pricing Information (provided that such finance provider or advisor is not an Applicant or the Principal Owner or Affiliate of an Applicant).
- (b) During the Standstill Period, Applicants shall not engage in commercial discussions with third parties that were not disclosed pursuant to Section 6.3.8(c)(ii) regarding potential changes of Principal Owners.
- (c) During the Standstill Period Applicants shall not engage in commercial discussions with third parties that were not disclosed pursuant to Section 6.3.8(e) regarding any commercial agreements or
