### 1 Introduction

Via <u>CRU/20/154</u>, published in December 2020, the Commission for Regulation of Utilities (the CRU) outlined the Regulatory Framework, Incentives and Reporting applicable to Price Review 5 (PR5), relevant to the period 2021 to 2025.

EirGrid TSO (the TSO) made submissions to the CRU in January and February 2021 with respect to the TSO's incentive related plans for 2021, the first year of PR5. The CRU's decision on the 2021 Balanced Scorecards was published in March 2022 via the CRU's PR5 2021 Balanced Scorecards Information Paper, CRU202226.

Per CRU/20/154, in relation to 2022 and later years, the TSO is required to submit TSO multi year plans to the CRU in October of each year to cover the next 3 calendar years in detail and years 4 and 5 thereafter at a high level, with the TSO consulting on same in parallel with the CRU's consideration of the TSO's proposed multi year plans.

In December 2022, the CRU published the PR5 2022 Balanced Scorecards Information Paper 2022, CRU2022989, which set out the CRU's Balanced Scorecards for 2022, following on from Network Company led consultations on the PR5 Multi Year Plans 2022-2026.

In June 2023, the CRU published the PR5 2023 Balanced Scorecards Information Paper 2023, <u>CRU202354</u>, which set out the CRU's Balanced Scorecards for 2023, following on from Network Company led consultations on the PR5 Multi Year Plans 2023-2027.

In March 2024, the CRU published the PR5 2024 Balanced Scorecards Information Paper 2024, <u>CRU202405</u>, which set out the CRU's Balanced Scorecards for 2024, following on from Network Company led consultations on the PR5 Multi Year Plans 2024-2028.

Consistent with last year's PR5 TSO Multi Year Plan 2024-2028 Call for Input Consultation, EirGrid is publishing this Call for Input Consultation Paper in relation to EirGrid's PR5 TSO Multi Year Plans 2025-2029. It is considered optimal to request input from stakeholders in relation to these plans in advance of EirGrid's finalisation of its proposed plans and submission of same to the CRU.

This consultation is relevant to the PR5 TSO Multi Year Plans 2025-2029 for the following EirGrid TSO PR5 incentives -

- RES-E
- Imperfections and Constraints
- Investment, Planning and Delivery
- Strategic Objectives, and
- Local Security of Supply

For the avoidance of doubt, please note that EirGrid will not be consulting again in relation to the PR5 TSO Multi Year Plans 2025-2029.

# 2 Call for Input Consultation

EirGrid has commenced the process of developing its PR5 TSO Multi Year Plans for 2025-2029 as required per CRU/20/154. EirGrid proposes to use the content relevant to 2025-2028 as detailed in its previously published PR5 TSO Multi Year Plans for 2024-2028 as the starting point for the PR5 TSO Multi Year Plans for 2025-2029. EirGrid will also take account of updates to programmes such as EirGrid's Shaping Our Electricity Future<sup>1</sup> where relevant.

Via this Call for Input Consultation, EirGrid invites stakeholder views on and input into the proposed approach in advance of EirGrid's finalisation of the PR5 TSO Multi Year Plans for 2025-2029 and submission of same to the CRU. EirGrid's PR5 Multi Year Plans for 2025-2029 as submitted to the CRU will inform the CRU's Balanced Scorecard 2025 Decision.

It should be noted that the TSO is currently preparing submissions to the CRU in Q4 2024 for the Price Review 6 period (2026-2030). The level of detail provided for the specific TSO Multi-Year Plans 2025-2029 may be tailored accordingly.
