# 1. Background

RESS 5 is the fifth Onshore Renewable Electricity Support Scheme by the Government of Ireland and is a pivotal component of the Programme for Government and the <u>Climate Action Plan 2025</u>. RESS 5 uses a competitive auction process to determine which generators receive support. For projects that are successful in the RESS 5 Auction, this support typically applies for approximately 15 years.

The RESS 5 Auction ran as per the <u>RESS 5 Auction Timetable</u> following the Auction Submission Closing Date on the 09/09/2025. The purpose of this document is to publish the Final Auction Results in respect of the RESS 5 Auction, as set out in Section 8.5.2 of the <u>RESS 5 Terms and Conditions</u>.

Since the publication of the RESS 5 Provisional Auction Results, one of the provisionally successful applicants (RESS 05-0305) was found to be ineligible to participate in the RESS 5 Auction and the project was disqualified and its participation terminated. This project has been removed from the list in Section 5.

These Final Auction Results are approved by the Minister for Climate, Energy and the Environment as set out in the RESS 5 Terms and Conditions.

# 2. Qualification

A total of 40 projects applied to participate in the RESS 5 qualification process. Upon publication of the Final Auction Results approved by the Minister for Climate, Energy and the Environment, 32<sup>1</sup> projects qualified to participate in the RESS 5 Auction. 5 projects did not qualify, and a further 3 projects formally withdrew from the process.

## 4. RESS 5 Final Auction Results

All 32 qualified projects submitted an Offer Price for their project by the deadline set out in <u>Section 3</u>. EirGrid ran the auction on the 09/09/2025. 22 projects (see <u>Table 3</u>) were successful, and 10 projects were unsuccessful in the auction.

#### 4.1 Weighted average strike price of successful offers


Table 2 contains the Deemed Energy Quantity (DEQ) GWh-weighted average Strike Price of the Successful Applicants.

#### 4.2 Deemed Energy Quantity successful and unsuccessful

A total Deemed Energy Quantity of 1493.28 GWh was successful, and a total Deemed Energy Quantity of 676.73 GWh was not successful. Figure 1 shows the Total Deemed Energy Quantity (GWh) successful and unsuccessful by Eligible Technology.



<sup>(1)</sup> Weighted Average Prices are calculated by multiplying individual offer price by individual Deemed Energy Quantity. This calculation is then divided by the sum of the total Deemed Energy Quantity.

### 4.3 Offer Quantity successful and unsuccessful




Figure 2 Offer Quantity successful and unsuccessful by Eligible Technology

In Offer Quantity (MW) terms, this represents a total of 1072.22 MW that was successful and 392.15 MW that was not successful. Figure 2 shows the total Offer Quantity successful and unsuccessful by Eligible Technology.
