# What are RESS Auctions?

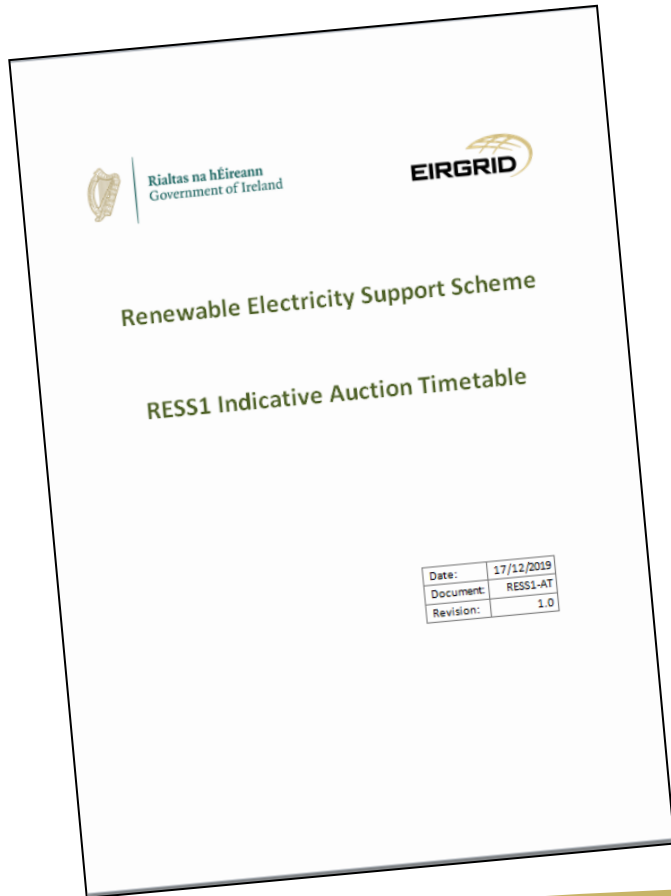
## Goal
